Kosovo Police, as one of the most important law enforcement institutions, besides achieving the main objectives and performing the legal tasks




## Prime Minister of the Republic of Kosovo, Mr. Ramush Haradinaj visited Kosovo Police

## Interview with the lieutenant Bajram Shabani from t

Protector: Honoured Mr. Shabani, the Directorate for Operational Planning and Evaluation (DOPA) where you work, has an important role in KP, could you please tell us what are the concrete duties of this Directorate? Lieutenant Bajram Shabani: The Directorate for Operational Planning and Evaluation is the part of the Public Safety Division within the Operations Department in GDP. Most of the commitments and tasks done within this Directorate are managerial needs of the Director of Operations, director of Public Safety Division dedicated to the regional directorates of Police that mainly deals with coordination, duties, guidance and operational planning of the general safety field.

According to DPVO operational needs, this Section has responsibilities to coordinate the police actions even with departments, directorates and other police units towards their positioning within the police organization, for general safety and operational planning in daily, weekly, monthly and annual basis.

The coordination of mutual activities according to the needs, is also done in other institutions of the Country, such as with the State



protocol, Presidency, Assembly, Government, various Ministries etc., and also other security agencies and organizations that operate in the Republic of Kosovo such as: Kosovo Security Force (KSF), Kosovo Agency of Intelligence (KAI), Agency for Emergency Management (AEM) Kosovo Customs

as well as in specific situations even with EULEX and KFOR, always cooperating through the contact points that we have with liaison officers of their mission.

The Directorate for Operational Planning and Evaluation (DOPA) conducts inspections throughout the local level about the imple-

mentation and respecting of the instructions given by the director of Public Safety Division or even by the Director of the Department for Operations through the operational orders, letters and various orders, about the implementation of strategic objectives and other police activities. This Directorate in the internal organogram has three various sections, divided according to various specifics of work, related to other issues and needs for the order and public safety. The consisting sections in Directorate level are: Section for Permanent Planning, Section for Operational Planning and the Section for Operational Evaluation.

Protector: Since one of the duties is also the planning of the visit of senior state personalities, where KP has the duty to provide safety even for VIP escort, how are the escorts planned and realized?

Lieutenant Bajram Shabani: When we talk about police engagements in providing the safety and escort of VIP-s, KP has the Close Protection Unit (CPU) which operates within the Special Unit Division (SUD) within the Department of Operations. For the CPU engagement for escorting local VIP-s

there should be done the risk assessment and threat by the Unit for Risk Assessment and Threat which in the structure is within SUD. After receiving the risk assessment, there are drafted the operational plans/orders and there are included all the operational actions of various KP segments engaged in providing escort, securing of VIP-s as well as in undertaking the public safety measures regarding the progress of the visit since the beginning until the end of the foreseen agenda.

Protector: What is the cooperation with other security local and international organization? Lieutenant Bajram Shabani: The cooperation, coordination of mutual activities avccording to the operational needs is done even with other local institutions but as well as with other security organizations operating in the Republic of Kosovo such as: Kosovo Security Force (KSF), Kosovo Agency of Intelligence (KAI), Agency for Emergency Management (AEM) etc., as well as in specific situations with EULEX and KFOR, always cooperating though the contact points we have with the liaison officers of their missions. The cooperation is at the right level and the coordination of all activities are carried out at an excellent stage.

Protector: Does the (DPVO) Directorate drafts operational orders even for other regional Directorates of Police and if yes, on which cases?

Lieutenant **Bairam** Shabani: Based on the guide for drafting operational plans/orders and the management of police operations from the Operations Department through the Directorate for Planning in GDP, there are drafted operational plans/orders (OO) and are further proceeded to other regional Directorates for implementation. In these OO-s, the organization of operational planning in various security levels, is realized and coordinated through resources from the central and local level as well as with expansion of operations into one or more regional Directorates of Police. For example, we have OO-s that are proceeded for implementation and there are involved more than one RDP, such as: anniversary of the Kosovo independence, visit of senior state personalities, where except the RDP-s in OO-s are also involved other KP departments, such as: Investigation Department, Border Police, Supporting Services etc.

# Theoretical aspects of dealing with general security and the ideological impact

Security, in general, increasingly is being considered a challenge for societies and institutions in general for security all over the world.

The method of confrontation between rivals, ideological or political one, includes a variety of actions that sometimes are unpredictable and hardly manageable even for most powerful states with highly developed mechanisms and agencies to face the danger and continuously undertake proactive and active measures in the function of managing general security. This can be underlined especially for the fact that along with the development technology more favorable conditions and circumstances for more coordinated approach and actions are created, including the propaganda in optimal time and space.

The propaganda actions effects as a result of fast spread of the information through this advanced technology that in many cases are related to the extremist ideology, in a way reach the indoctrination in one hand and creation of panic in another one, for

certain groups or society in general, where often creates confusion in the security aspect.

Our country as well was impacted by such developments where various ideologies are clashed in attempt to dominate one another and the conflicts throughout the world have electrified certain elements in our country to be involved in inciting and supporting various (terrorist) organizations, allegedly for spreading the various ideologies or causes. The society and state's security institutions in the Republic of Kosovo are following carefully the security situation by having an active cooperation and mutual role in prevention and reducing of the impact of spread of the of extremist ideologies as well as the isolation of their propagandistic elements. The tolerance and cooperation of our citizens with the relevant institutions is an advantage that ranks our country as a successful one in the fight against terrorism. Kosovo police has played very important role in addressing this problem and activating all other actors in the function of improving the general security conditions. Kosovo iust like the other cannot be immune against unpredictable terrorist actions that may occur, although our country managed to have under control the elements that have been evaluated as potentially related to the individuals or terrorist cells and based on the situations there have been actual cases of prevention of such actions that

The tolerance and cooperation of our citizens with the relevant institutions is an advantage that ranks our country as a successful one in the fight against terrorism

might have resulted with unpredictable consequences.

Although Kosovo recent years has undergone some fragile economic, political and social processes, Kosovo Police based on its legal scope, continuously undertook professionally operationalmeasuresinordertoprovide order and security in the country, as well as normal functioning of state's institutions. Except guaranteeing the function of the institution, through an active professional and transparent work, with the society and media, was achieved high mutual trust, which makes Kosovo Police one of the most transparent and credible institution in this part of the region.



Kosovo Police, in addition to numerous activities, has undertaken additional activities in providing safety for the children, especially pupils, conducting lectures on schools and kindergartens, as well as performing checkpoints near schools. This was done with the aim to raise greater awareness for knowledges and in respecting the road traffic rules. Based on the data of fatal accidents that

have occurred during the September 2017, from eight (8) accidents with fatality, ten (10) persons have died, from them five (5) drivers, three (3) passengers and two (2) pedestrian. It is worth mentioning that none of the persons died in the traffic accidents for this period, has not been under the age of eighteen (18).

Referring the number of pupils and





their movement from the house to the schools or from the school to the house, Kosovo Police urges that: in order to increase the vigilance, the parents and pupils should be more careful when participating in road traffic. Special care should be taken by the vehicles drivers to respect all the rules arising from the road traffic law, to guarantee a greater safety and to avoid the traffic accidents on the roads. Otherwise, Kosovo Police for all the participants who contradict the traffic laws will continue to apply the legal measures and there will be zero tolerance.

## THE ROLE OF YOUTH IN IDENTIFYING AND PREVENTING RADICALISM AND VIOLENT EXTREMISM LEADING TO TERRORISM



Life of people throughout the world has become more advancement and dynamic, personal and social needs in the field protection and security have increased and changed tremendously. Since the change and advancement of ways of committing and the trend of crime, the change of the way and development of the dynamics of movement of people and goods, the fast advancement and great use of technology, challenges present in the past in the security aspect in the community requires a pragmatic approach of the law-enforcement bodies. One of the elementary needs for development of democratic societies is certainly the advancement or the perfectness of the justice system through providing loyalty and qualitative services for the community members. Taking into consideration various researches throughout the world, realized in various fields of negative phenomenon, mainly in the identification field, prevention and combating radicalism and violent extremism, it is evident that the training on terrorism is not enough through the reactive or repressive approach against suspects with radical tendencies and potentially with manifestation of violence, but a special and very important role has the proactive or soft approach against this phenomenon. Actually, the adequate and serious treatment and of the proactive approach in prevention of radicalism and violent extremism, potentially leading to terrorism, is an approach with long term results and prevents spreading extreme ideologies to the population in general.

Police Directorate in Community and Prevention, respectively the Section on Prevention of Violence and Delinquency of Juveniles, in cooperation with the Directorate Against Terrorism, respectively the Section on Prevention, based on the Strategy and Action Plan 2017-2021 "Community Policing" respectively strategic objective I, II and III, has the main aim to serve in raising awareness of pupils about the concept of community policing and their role in identifying and prevention of terrorism in general.

Furthermore, organizing this youth camp is done with the aim of increasing the awareness of pupils about their role, in identification and potential prevention of radicalism and violent extremism, shall contribute in mutual exchange of information with com-

munity, respectively youth and lawenforcement officers.

In this youth camp there participated pupils, education personnel, representatives from the civil society from Primary School "Qamil Batalli" and the Primary School "Pavarësia" from Prishtina, Secondary School "Zenel Hajdini" from Gjilan, Secondary School "Vëllezërit Frashëri" from Deçan and Secondary School "Kuvendi i Arbërit" from Ferizaj. Professional police officers from specific fields who lectured about the topics, such as violence on schools, delinquency of minors, abuse of information technology and social networks of communication, prevention of consequences from the use of narcotics and prevention of radicalism and violent extremism leading to terrorism. During this youth camp there have been conducted various activities from the children in groups who have shown their ideas and creativity about how to advance the sincere cooperation between youth and Police, how to identify potentially radicalized persons and potential efforts of youth for potential de-radicalization of radicalized persons.

# VITAMIN'D'IS ESSENTIAL PART OF HEALTH

Vitamin 'D' is a quite important and

unique vitamin for the human body. It functions as prohormones where under the action of sun rays, the body may synthetize it, means from the UV sun rays, B. Therefore, it is preferable to sunbathe 15-20 minutes during one day, without using sun creams, in order to get enough vitamin D. This vitamin can be also provided through the food such as: fish oil and milk productions etc, which have a great importance. The main biological function of vitamin D is to maintain normal levels of calcium and phosphorus in the bloodstream, affecting in absorption of calcium which then results in strong bones, in the immunity system due to its bacterial properties and in prevention of various diseases, including

diabetes, asthmatic crisis, malign diseases, foetus development (here is the importance that a pregnant women should obtain this

vitamin) etc.

The lack of vitamin D has become a widespread disease. It is followed by a lack of chronical energy, fatigue, lack of immune force, pain in bones, frequent bone breakage, osteoporosis which results in muscular or bone weakness, depression, loss of memory (to the elderly), it incites pain and deformities in bones (to the children), pain in muscles, etc...


The lack of vitamin D comes as a result of the work in closed environments, such as, office, various premises, during the night shifts, non-adequate feeding, to the diseases when the kidney cannot convert the vitamin D into active form,

the overweight, etc.

Sun rays are the first source of vitamin D, especially during the winter season when the day is shorter and the possibilities to get rays are fewer.

All these consequences from the lack of this vitamin as we mentioned before, come from the lack of sun rays and it is worth mentioning that it is dangerous for the officers who work in closed environments inside offices 8 hours a day and these consequences pose a risk for their health.

We recommend you to measure the D vitamin in blood, in order to find out if we have lack of D vitamin and to avoid the consequences of this vitamin and to

## IN THE FOCUS OF POLICE ENGAGEMENTS IS ALSO THE IDENTIFICATION OF CHILD BEGGARS AS POSSIBLE VICTIMS OF TRAFFICKING AND THE COMBAT OF THE ABUSE OF CHILDREN IN GENERAL

The phenomenon of begging is a concerning phenomenon and it still remains present. Every day we notice children and adult begging on the streets, cross-roads, pubs and various premises. These persons, especially children, while staying lying down in the street for hours, moving or cleaning vehicle fender, their life in road traffic is always in risk, these children walking around the streets until late at night, may also be potential victims of crime or trafficking.

According to the law for public peace and order, the phenomenon of begging is an offence.

Kosovo Police, respectively the competent units with its officers, pays special focus to the protection of children on the road, because children may be potential victims of abuse, crime and trafficking, and this phenomenon should be also priority of other relevant institutions dealing with this problem.

Police, in addition to the measures coordinated with other actors, where there are elements of criminal offence, including the trafficking in human beings or organized crime, also undertakes investigative and operational actions, and for each case the public and media are informed consistently.

In a case, the Directorate for Investigation of Trafficking with Human beings has drafted the operational plan "Identification of child-beggars, as possible victims of trafficking", which was implemented throughout the country on 5th of July 2017. The implementation of this police operation was aimed at identifying victims of trafficking and reducing the presence of child-beggars in the streets.

The operational plan was also supported by other relevant actors, such as: courts and prosecutions of respective regions, Centre of Social Affairs, Directorate for Migration and Foreigners within KP.

During the implementation of this operational plan, there were undertaken the following actions:

- -There are identified thirty two child-beggars (20 citizens of Kosovo and 12 citizens of Albania),
- There are identified twenty one child-beggars of adult

age (15 citizens of Kosovo and 6 of Albania),

- There were arrested four persons, suspected for being involved in the criminal offence "abuse or abandon of children" and eleven criminal charges have been filed. The foreigners were taken for further procedures in the Directorate for Migration and Foreigners to continue with other actions based on the Law on foreigners.

#### KOSOVO POLICE AND AMERICAN (DEA) HAVE CARRIED OUT A JOINT OPERATION

Kosovo Police, Division against the Organized Crime, respectively the Directorate for Investigation of Trafficking in Narcotics (DITN) in cooperation with American (DEA),



after several month investigations have carried out three police operations. The investigations were conducted in close cooperation with American officers of both countries. The two operations were conducted in the Republic of Kosovo (region of Peja) and in New York. In this operation have also participated: the Directorate of Special Units, Directorate for Support of Investigations, Directorate of Forensics and other police units in coordination with Special Prosecution and the competent court.

The first operation was carried out on 18th of June 2017 at about 18:30 o'clock, while the second operation was carried out on 27th of June 2017 at about 19:45 in Klina. The operations have resulted on arresting of four (4) persons in Kosovo, six (6) persons in New York as well as there were confiscated weapons and other material evidences

Weapons and other evidences confiscated during the operation:

- 15 automatic weapons AK-47
- 120 bullets, 7.62 mm
- 1 anti-tank (grenade launcher)
- 1 pistol
- 1 air rifle
- 63000 € (sixty three thousand euro)

By the order of the competent prosecutor, the suspects were taken to the detention centre for further legal proceedings.

#### KOSOVO POLICE WITH A CONCRETE PLAN "STOP DRUGS IN SCHOOLS"

Kosovo Police, respectively the Directorate for Investigation of Trafficking in Narcotics in order to achieve the objectives and activities foreseen in the National Strategy against the drugs and legislation in power, consistently during this year and the years we left behind has conducted successful operations in prevention and combating the trafficking with narcotics.



During the police operations there was confiscated a considerable amount of narcotics, a great number of suspects have been arrested as well as were destroyed criminal groups and all these actions were published through the press releases.

Police in cooperation with other relevant authorities is consistently working in prevention of the cases related to narcotics, however in the legal aspect there will be undertaken tough measures against all the persons involved in trafficking with narcotics and other illegal actions that risk the health of youths.

A special operational plan has commenced to be implemented in the Country, according to the Operational Order "Stop drugs in schools" where police activities in the field of prevention and operations are being carried out and will be carried out in the future.

In the field of prevention, visits and contacts with the school staff were carried out, in cooperation with the Family Medicine Center lectures were held, leaflets were distributed and police officers were engaged in patrolling around the schools.

While, in the operational field there were checked persons who frequented the security area of 300 m around schools, there were also controlled vehicles, premises and other suspected cases.

To conduct such activities, there are engaged police officers from: the Regional Directorates of Police, Police Stations, Directorate of Policing in Community and Prevention, Directorate for Intelligence and Analysis and the Directorate for Investigation of Trafficking in Narcotics. Kosovo Police remains committed in the combat against criminal offences, including trafficking in narcotics.

## EIGHT (8) SUSPECTS ARRESTED FOR 'ENABLING IN PROSTITUTION AND PROVISION OF PREMISES FOR PROSTITUTION' AS WELL AS 'DEALING WITH PROSTITUTION'

Kosovo Police, respectively the Directorate for Investigation of Trafficking in Human Beings, in the framework of investigative-operational actions, with the aim to prevent the crime and combat all the negative phenomenon, including also criminal activities, during July 2017 successfully has carried out several technical operations.

The police operations have been conducted on different regions, such as in Prishtina, Ferizaj, Mitrovica etc., where as a result there were arrested eight (8) suspects involved in the criminal offence 'enabling in prostitution and provision of premises for prostitution, the criminal offence 'dealing with prostitution. There have also been confiscated material evidences which can be used for legal proceedings.

These illegal actions apart damaging the image of the country, increasing insecurity in society and family problems, they also impact in the citizens health, since, the Police during the implementation of operations has also encountered persons that have exercised the activity of 'dealing with prostitution' and who have been infected with various diseases. Therefore, we urge the citizens to avoid such activities and for any suspected case to inform the Police in order for them to undertake prevention measures.

## Central archive and the mission of the archivist in Kosovo Police

The Central Archive Sector in Kosovo Police, based on the organizational structure, operates within the directorate of internal services-Division of Personnel and Administration and has two organizational units, the unit of archive and the unit or central register, where the employees perform certain duties and responsibilities, who provide efficient services based on the professional education.

For functioning of this sector there was drafted legal bases and internal regulations in the field of managing official documents in the line with the Law on State Archives, other relevant laws and International Archiving Standards. This Sector operates by implementing work regulations, standard operating procedures, list of categories of archiving documents with storage deadlines, there are regulated "administrative codes of classification of official documents" etc.

The archive and archived file is handled based on the unique regulations and professional instruction of the sector where is determined the work methodology in managing documents and handling the archived files of police up to the access and use of documents in addition to legal infrastructure, internal regulations there are created appropri-

ate conditions in safe environment with modern inventory mobile metal shelves (special), surveillance cameras and archive warehouse as well as necessary equipment that makes the archive functional in accomplishing the objectives determined by the plan of our sector and the annual work plan.

The Central archive sector is the only sector within the GDP that deals with the management of the official documents, collection and preservation of archival fund and it is well organized, it has work methodology where the concrete action procedures are developed. It is a place where the archive material is received, classified, evidenced, preserved, protected and published, where its use is open for official use, operational use, scientific researches and professional work as well as other

issues in the interest of the institution. The archived material and official documents of police are protected by the Law and sublegal acts that regulate this field.

The police archived material, is a sum of letters, documents dealing with the same issue or task and create and special entirety. The material is composed of documents which are related to one another during the performing duties in to a task or in a field of activity. The archived material is also an evidence of the way how an activity was carried out while its value is administrative and testimonial value. Documents consisting one file must not be separated from one another, outside this context the documents loses its meaning and information value. "Any Document has its own place in the file, while every file is a part of a fund"

- The archive ware house is an important part where the archive material of police is preserved in an adequate space with all preconditions for an efficient organization in preservation and protection of archival material according to the contemporary archiving standards.
- The archive unit makes the evaluation (valorization) of documents where it is determined the value analysis and evaluation of official documents (storage term), based on the origin of documents, content, character, sensitivity and other elements.

The evaluation is done with the aim to, from the minimum of documents to be gain the maximum of information.

- The Central Register manages all the official letters/evidencing, where the the basic evidences of the work are the protocol books, the plan of classifying signs (according to the organizational structure), registration of acts, additional books, etc. In this unit is also done the receipt of letters (post), opening, controlling and evidencing of post, evidencing of letters, administrative-technical processing of material, sending of letters/post inside and outside the Police, work deadlines and other activities within this service.
- The mission of an archivist and professional duties. As a primary duty of an archivist that serve in the central archive is the storage of documents trusted to him and which documents are evalu-



ated, registered, selected, preserved, protected etc., in accordance with the legal provisions of archivist and general standards for handling the materials in archive.

- The archivist evaluate the documents objectively, impartially and based on their opinion on the basis of the recognition of administrative and legal needs of the section.
- The archivists keeps the reliability and integrity of the archive material and provide security to the documents during processing, protection and use, they guarantee that the documents are acceptable and understandable.
- They are engaged in preserving the documents by cooperating closely with the material creator in applying of necessary standard forms.
- The archivists are responsible to care and protect the archival materials, to respect the legal provisions, the rights of users as well as to coordinate with the units that forward the material in the archive.
- The archivists give explanations to the

- users regarding the rights and restrictions during the use and implements them rightly.
- The archivists respect the freedom of access and the private right, they act in accordance with the legal provisions, and the given authorizations must not be used for personal benefits or any other benefit.
- The archivists oppose any pressure that aims to manipulate the evidences, concealing or falsification of evidences
- The archivists must not detect or use the information taken by the archival funds, they must not allow that their personal interests for researches and publishing contradicts their professional duties.
- -They do not allow anyone of any other field to interfere in their tasks and professional duties, they keep secrets of official documents and are responsible for their destruction, loss and abuse.
- The archivists are important participants in the process of transferring the information from one to another generation. Except these duties, they should consider other functioning related to their mission.

The work of an archivist must never be isolated and separated of other similar activities. The central archive and other archives in Kosovo Police are a documented wealth, treasured chest that save the memory and the past since the establishment of this institution.
