"Kosovo Police is a success story", it was written and mentioned in many national and international articles and analysis by people with influence in social life in Kosovo and beyond.



n 24 of March, 2013, a trilateral meeting was held between the Kosovo Police, EULEX, and state Prosecutors in the facilities of the General Directorate of the Kosovo Police. At this meeting the leaders of the two institutions discussed various ways to enhance cooperation between the two institutions for combating crime. The meeting was organized and facilitated by the EULEX Division of empowerment.

In the meeting there participated the General Director of Police, Mr. Shpend Mexhuani, and senior representatives of the Police, including Regional Directors, Mr. Alexander Lumezi, Chiefprosecutor of the Appeal Prosecution, Pristina, and the Chief Prosecutors of Kosovo prosecution offices from all regions of Kosovo and the Head of the Division of EULEX empowerment, Peter

Through a joint action plan between police and prosecutors, facilitated by EULEX, the implementation of best practices of cooperation begins

Bach, police advisers of EULEX prosecutors.

General Director of Police, Mr. Shpend

Mexhuani, in his speech welcomed the participants and then his discussion was focused mainly on increasing the cooperation between police and prosecution, in order to have a more effective approach in combating crime in the country.

"I wish that this beginning will serve us, as main responsible persons, according to the legal powers, to fulfill our mission we have, which is combating and preventing crime. Kosovo police will be available and open for all cooperation at all levels, as required, "said Mr. Maxhuni.

Also at the meeting the Chief Prosecutor of the Appeals Prosecution Mr. Alexander Lumezi took his word, who said that officers of the prosecutorial institutions are now ready to face with the situations related to the consolidation of rule of law. He further added: "These

joint meetings with the Kosovo Police are in that spirit and I think that they will be welcomed in order to improve the activity and daily work of the Prosecutors and the Police in combating organized crime and corruption".

Also at the meeting there was discussed the cooperation of local and international institutions, a cooperation that is growing.

The head of Division for empowerment of EULEX, Mr. Peter Bach, said that the increased cooperation is a key requirement for the EU and visa liberalization. "One of the requirements for visa liberalization is a good combat against organized crime and corruption. Today the mission is helping Kosovo Police and Kosovo prosecutorial service to facilitate this cooperation, in order to achieve better results, "said Peter Bach. In a meeting, also the two institution representatives, the police and prosecution contributed with discussions, expressing willingness to increase cooperation and sharing positive experiences of the so far cooperation.



This meeting will be followed by regular meetings at the regional level between the Kosovo Police and Prosecutors to coordinate a common approach for reducing investigations and crime. A special attention will be paid to the training of prosecutors and police investigators, presenting best practices of cooperation of such institutions as the

police, prosecution and other agencies of security. This cooperation aims to build capacity within two institutions in order to transfer responsibilities to local institutions of cases investigated so far by EULEX investigators.

"Say no to narcotics"

Over 1400 young students from various schools through lectures, discussions with police officers, have got information about the consequences of the use of narcotics Police officers of the Police Directorate of Community and Prevention and the Directorate of Investigation of Narcotics Trafficking, except the operational police work in cooperation with the Ministry of Education, Science and Technology, with the aim of raising awareness of the country's youth about the conse-

quences of the use of narcotics, since October 2012 have started implementing the project "Say no to narcotics". This project is being conducted through lectures and meetings with students and young people of all the towns of Kosovo, where the focus of this project are students of secondary schools as well as elementary schools, higher grades.



Lectures and discussions are focused on the following topics: "The prevention of the narcotics use, consequences of narcotics' use and the cooperation with the police and school staff about reporting suspected cases of narcotics' use." Also within this project debates



and meetings are being organized in the municipal departments of education, school directories, meetings organized by the students' councils. Several debates were organized where it is worth noting that there has been great interest of young people about topics of discussion. Through this project KP aims to sensitize the general public about the negative effects of narcotics' use, seeking cooperation for prevention of such cases, in order to save the health of society and the development of a healthy youth. Since the beginning of the project, beneficiaries of lectures and information during 2012 to March 2013 have been more than 1486 students.

COMMUNITY POLICING IS THE FUTURE OF KP

since this new police methodology begun its implementation, it had in focus the partnership with citizen, many strategic documents are approved and many concrete changes are done even at station level, respectively regional directorates. To know more about KP activities in this direction, "Protector" interviewed the coordinator for implementation of community police strategy, Colonel Shefqet Begajn.

'Protector': You are appointed by the general director as a coordinator for implementation of the strategy and action plan of the community policing, can you tell some important activities implemented since this strategy was approved?

Shefqet Beqaj: The Strategy is approved on May 2012, but this strategy was preceded by many activities. By the approval of the Strategy and Action plan a working group was appointed for implementation and activities be-

gun according to the action plan. Some of the main activities achieved are: we fitted the organizational structure to the concept because it was needed to foresee section work and to divide it from the other activities or activity of responding to cases, let us call it respective activity, and give importance to the preventive aspect. We divided the police station territory in sections and all police stations now have their territory divided in sections, leaders of sections are selected and appointed, also staff

for section is selected. According to the assessment of the police stations, in every police station we selected and appointed one coordinator by structure, each for the work of sections in order to coordinate section and inter section works and also other services as: investigations, and other police works in general.

'Protector': Have the training for the police officers appointed to work in sections started?

Shefget Begaj: We have started the trainings, a great job is being done, around 2000 persons are trained and trainings are going on. An amount of trainers was created, and they are continuing with trainings at the police stations. We have performed also other activities according to the action plan and there are continuous activities that we are undertaking on expanding work in section. Normally there are many problems and challenges we are facing but I hope a great job was done and we are in a good way for implementation, but we are very aware and prepared to work on long terms, because it does not matter who implemented this methodology for short term and I don't think that we will do it in short term, but we believe that with our mobilization, works are going in the right direction.

'Protector': You stated briefly that you faced problems and this is not novelty because even other police organizations faced with these problems in the beginning of implementation of this police strategy, aside from these problems and challenges, what would you consider as a greater challenge, is it the issue of human resources management and lack of human resources at the respective police station levels, the first one:



'Community policing is the future of police and by the time they will see that this will be the main pillar of crime prevention and offering safety to citizens'. are you faced with any kind of passive resistance by the police officers against community policing.

Shefqet Beqaj: The issue of human resources is very present because we have a certain amount of police officers in the Kosovo Police who acted, are acting and are authorized, but from the moment that this number was appointed up to day many more services and units are created, and they recruited staff from police stations so the staff of the police stations is being reduced every day. I said earlier that today is the last day that a new unit was created which will recruit further the personnel from police stations, even some stations will be taken a significant number of staff, it is about unit of securing cultural heritage facilities. In fact some of the facilities so far have been secured from police stations but now we will not be have that staff available, because although sometimes they were used to provide those monasteries, buildings etc. security they were also used for other needs. Now they will not have these opportunities anymore, because it is made, a central unit is created, it is a time request. In one hand it is a staff, the second it is true that there is a resistance, silent one. It is taking time for people to understand that it is a philosophy which is embraced by all advanced police in the world. We are also going through these difficulties that those police organizations have gone through, and some of them even took decades, I can say that those police organizations are ongoing through these reforms even today and they want to do something better or to advance this methodology or philosophy of work. We are still at the beginning but I am very optimistic that the new methodology or sector work will be extended and it will work and it will deliver results and am very confident in extraordinary results.



'Protector': We are one of the youngest police organizations in the region, since it was established and started the work in September 1999, at the same time we are facing a problem that other police in region do not have, the problem of average age. Before new generation start work, average age in Kosovo Police was 42 years, is the average age of Kosovo Police a problem for the implementation of the strategy?

Shefqet Beqaj: As for the implementation I don't see any problems, but yes in other fields and that is for sure that we need to regenerate our lines. As for the implementation i don't see any problems because this section activity does not require any king of dynamism like other specialized units, preventive work is more required.

'Protector': You stated that everyday new units are being established in Kosovo Police, the recent one is the Unit of cultural heritage management and securing them, as a coordinator, will it be one of the recommendations at the pillar of human resources for recruitment of new staff and would it be supported financially by the Kosovo Police?

Shefqet Beqaj: We have the exact number of officers in Kosovo Police which is 7335 and that is a fix number.

Whether the senior staff of Kosovo Police will be able to forward the request to enable financing a greater number of people, because the needs are increasing every day, it is another issue. Another issue is whether the government will have the ability or the will to allocate budget for a number of police officers, i.e. 500 or 600, because a great number of police officers at the moment are performing entirely non police works like securing various facilities, like governmental, embassies and now cultural heritage etc. So it is an extraordinary great number.

'Protector': Another question for the trend of criminality and the issue of reduction of fear of crime. This problematic was present in all police organizations when they entered these reforms, the trend of criminality raised, but various researches show that fear of crime is reduced. Are you following this criminality trend, fear of crime or reaction time since this sector division has started work?

Shefqet Begaj: Yes we usually follow these trends, we can say that we do not have any major movements but surely as time passes those problems are going to appear here also. I would say that the increase of criminality and the time of response in some locations are as a result of small number of police officers dealing with those jobs because the number of police officers in some police stations and some cities where these problems are greater. Units, starting from the border one, investigation unit established, cultural heritage, new traffic units, have collected the staff from police stations. Not only have taken them as a number, but maybe they have choseng best and most successful boys and girls.

'Protector': What would be your message for all police officers especially those working in sections?

Shefqet Beqaj: Section or community policing is the future of police and by the time they will see that this will be the main pillar of crime prevention and offering safety to citizens.

It is a job that, among other, brings joy to offer services of profession they have chosen and they are paid for. It is truly satisfaction to offers safety to the citizens within the section, that is the future of police and true people that will prevent crime through cooperation with citizens.

rom 1 June of this year at two border crossing points Qafa e Morinës and Qafa e Prushit linking the Republics of Kosovo and Albania, has started the implementation of the agreement of border checks facilitation at entrance-entrance, exit-exit, based on the practices foreseen with integrated border management as well.

Kosovo Police and Albanian one already have a regular approach on fa-

cilitation of border control started years earlier at border crossing point Vermica, an approach that showed positive results in crime prevention and the possibility of establishing and facilitating border crossing.

Border police authorities in Qafë-Morinë and Qafë-Prush have already done all the preparations, increasing Implementation of the agreement for facilitation of border checks with Albania in border crossing points

the number of police staff and they are ready to deal with the flow of all citizens, tourists who choose to use these two border-crossings to cross the border from both sides. According to police estimations in previous summer seasons, the number of people who pass by both sides in the two border crossing points is increased. This qualitative step in cross-border practice is another indication of police coopera-

tion between Kosovo and Albanian Police, creating greater opportunities for citizens on both sides of the border, in order to move freely, without delays and it simultaneously brings further development of economic, cultural and human exchanges.

HOW DOES THE HEALTH S

epartment of Health Services has the beginnings of its development in 2000 which began work on the initiative of the international police officers, while competencies have been received by the local authorities in October 2004.

Department of Health Services within the sections: A-Section of Medicine and Promotion of Health, B- Psychology Section, and C- Office of Administration, offers medical and psychological support to the staff of KP as well as recommendations for various medical requests of personnel of KP within the Department of Human Resources.

In the section of medicine and promotion of health in Kosovo Police there work five (5) doctors and a nurse.

The staff of the department is constantly professionally improved in order that the services to KP employees to be more effective and more efficient.

Doctors are already at the end of their specialization phase where thanks to

an agreement of understanding with the Ministry of Health, KP doctors were allowed to make specialization in different profiles for KP needs.

DHS now has two specialists: an internal medicine specialist and an epidemiologist, while at the end of their studies there are doctors of the fields of gynecology, clinical psychologist, internist and neuropsychiatry.

The psychology section is comprised of psychologists and coordinator of the team for counseling and support / regional advisors), while the Office of Administration includes:

Medical visits for police personnel, staff visits for the injured or sick personnel depending on where they are at home or in the clinic.

The aim of the visit is the health and psychological support and familiarizing more closely with their health status, the result of which is the provision of support by the DHS.

Engage in police operations according to operational plans





Medical staff (doctors, nurses), the section of Psychology, Counseling and supporting team of DHS with the medical ambulance responds to operational orders of police operations of middle and high level of risk, in order that in case of need to have a quick access in order to provide medical assistance to personnel of KP in police operations.

Recommendations for various medical requests for KP staff

DHS recommends, according to its SOP's, medical requests such as: Recommendations for regular requests of sick leaves / GPD, requests for exemption from uniform and professional equipment, requests for sick

leave without pay, medical requests for special health cases (as diseases defined by the Administrative Instruction no. 07/2012 on work relation in Kosovo Police), requests for treatment abroad, requests for rehabilitation in rehabilitation centers (very important for staff of KP injured on duty for rehabilitation opportunities, as well as special medical cases, requests of material compensation (there should be noted the material support for officers injured on duty and special health cases, attempting to give a significant material support, considering the lack of health insurance for personnel of KP).

Then we have initiations for medical and psychological examination for the personnel of KP in the authorized clinics of KP, where DHS acts according to SOPs of DHS.

It is worth mentioning that last year by DHS there were recommended 252 cases of medical services for personnel of KP in a value of 184,294.33 euro, then 75 members of KP have undergone the rehabilitating treatment and physical therapy in a value of 14,250.00 euro, and 17 payments for the authorized clinic of KP for medical and psychological examination in a value of 48,519.02 euro.

Last year the number of voluntary blood donors has reached 317, where as the leader was the Camp Vrella Special Unit and members of the Police Academy in Vushtrri. The purpose of voluntary blood donation shows the human side that the Kosovo Police has for the national interest.

Then we have the preparation a brochure with articles about the most common health problems among members of KP.

So far DHS has issued the following brochures:

- 1. Heart attack
- 2. Pain in the back

- 3. Hypertension Arterials
- 4. Post Traumatic Stress Disorders (Department of Psychology)
- 5. Premenstrual syndrome and menopause etc.
- 6. Family planning and contraception

7. Flu pandemic

By this department there is also provided psychological support to police personnel who may be concerned on duty and on the line of duty. This is achieved thanks to the dedication of Psychology section through counseling sessions, home visits for staff that need psychological support, treatment by KP psychologist and the one authorized by the clinic of KP.

DHS's goal is the realization of technical and medical conditions (equipping with health ambulances of specialist profiles that KP needs, and ambulance of clinical psychology, in order to provide medical and psychological support to all staff of KP, without having external cost and early detection of diseases with the aim of longevity.

ike previous years, this year the Kosovo and Albanian Police will jointly patrol along the streets of Albania in order to create a safer environment for all the people who will use this country for vacation during the tourist season.

This comes after signing the cooperation agreement by both police chiefs, General Director of the KP, Shpend Mexhuani and General Director of the Albanian State Police, Mr. Burgaj in Tirana for joint patrolling in the roads of Albania during the summer season.

In a joint conference on signing of this agreement, the General Director of Ko-

sovo Police, Mr. Shpend Mexhuani said: "The cooperation that started 3 years ago, and on basis of mutual evaluations, we conclude that this approach has created concrete actions. Strategic level actions have a purpose: increasing safety in the roads. We urge you to be careful because only in this way we prevent accidents. Kosovo Police has taken measures to successfully implement this plan and has undertaken actions in advance to make border crossing easier".

While, on the other hand, Mr.. Burgaj, director of the State Police, said that during the meeting with his counter-

part, issues of cooperation also in other areas have been discussed, such as cross-border cooperation with Kosovo. "This service also in previous years has been a successful service for facilitating the citizens of Kosovo to use the tourist places of Albania. Within these measures, police services, would create the necessary facilities to the citizens of Kosovo without causing any hindrance in their movement throughout the territory of the country. In cases found to be violation of traffic rules, police officers will warn and make a report and submit it to the Kosovo authorities. No action will be taken except when there is a criminal offense. This is new, as citizens of Kosovo have spent a lot of time dealing with documentations or things of that nature, "said Burgai. This agreement will be implemented in the period from June to September 2013. At a meeting in Tirana both directors have discussed the establishment of cooperation in other areas, in order to coordinate actions for the purpose of crime prevention at both sites.

Based on bilateral evaluations, the cooperation between two police organizations in this regard has been very successful, contributing to reducing the number of offenders and in decreasing the number of road traffic accidents.

Intelligence

Kosovo Police through the implementation of the strategy and action plan "Intelligence Led Policing" 2010-2012, have achieved to realize a considerable progress on implementation of this work model, therefore to proceed with the implementation of this model, police have drafted the new strategy "Intelligence Led Policing"

e aim of this strategy and action plan is to strengthen the implementation model "Intelligence Led Policing" in the Kosovo Police.

The strategy "Intelligence Led Policing" as a modern policing methodology will enable the Kosovo Police a pro-active approach to the problems and would increase the efficiency in performing police duties. Through the implementation of this document it is also intended that the Kosovo Police management based on the results and analysis of the intelligence product to be ready in time in order to take concrete decisions.

This strategy and action plan "Intelligence Led Policing" is designed in that way so all the levels of the police organization would enable a fully functioning of the intelligence process, enabling inclusion of all the employees of KP. This

process has the aim to fulfill the Kosovo Police mission and strategic objectives derived from the "Strategic Development Plan" of KP, as well as fulfilling of the mission of other strategic documents (national and sectional) through the strengthening of capacities within the Kosovo Police, advancing of the information and communication technology system, strengthening of cooperation and coordination, as well as other practical activities necessary for the fully functioning of this process. Drafting of this strategy and action plan has preceded the evaluation and analysis of the current situation, that has resulted in identification of certain areas that needs to be further strengthened, in order the entire intelligence process to be in function, starting from the collection of information up to the assignment of duties and coordination, as well as priorities of the organization. The model "Intelligence Led Policing" recently has shown a wide adoption trend from the most law enforcement agencies, especially in EU countries, model which is closely supported by the Policing in Community".

Therefore, during implementation of this document and respective action plan, Kosovo Police has paid special attention to the implementation mechanisms, which are closely related with the "Policing in Community", focusing in inclusion of the community concerns and prioritization of the Police in order to create a safer environment for all the citizens of the Republic of Kosovo.

Continuance of implementation of this model will enable Kosovo Police to apply contemporary police methods, proactive approach, planning and efficient management of resources, as well as better organization of the work.

Led Policing



I. UNDERSTANDING OF PHILOSOPHY "INTELLIGENCE LED POLICING"

Intelligence Led Policing (ILP) is a work model and management philosophy, where the intelligence products find a wide use in decision making process and has the aim to prevent and reduce

the crime and problem solving focusing on elimination of causes through the strategic management and effective implementation of the strategies. ILP, highlights the police intelligence as a part of democratic police, which respects the normative acts and human rights that are the basis of a modern police. Police should be in service of citizen needs, be responsible to the law, respect and protect the human rights and to be transparent in its activities.

II. CURRENT SITUATION

Kosovo Police through the implementation of the strategy and action plan "Intelligence Led Policing" 2010-2012, has achieved to realize a considerable progress in implementation of this work model.

Significant achievements are marked in implementation of the activities foreseen in the Action plan of this ILP, as in increasing of capacities of the Kosovo Police in fulfilling the mission and vision of the organization as well as in raising the awareness level of police officers for the ILP importance, and the opportunities offered by this work methodology. Taking into account the ILP importance a considerable number of the activities foreseen with the Action Plan of ILP are adopted in the action plans of almost all departments of Kosovo Police. These results are mainly focused in the awareness field of the police personnel for the importance of intelligence process through various trainings, starting from the basic level up to advanced intelligence trainings

for the officers involved directly on intelligence duties.

Other mentioned achievement are the progress achieved in harmonization of Standard Operation Procedures, job description for all the employees in Kosovo Police in harmony with the Intelligence Led Policing model, determining of the organizational structure to the needs of this model as well as other achievements that are mainly related with normative and procedural issues. However, with the whole achieved progress, there were appeared also challenges and difficulties that directly or indirectly have impacted in non-realization fully or partially of some objectives and main activities of this strategy. Cooperation with other regional, state and international institutions for the exchange of information should be further developed and advanced. The lack of technological capacities and human resources presents challenge in fully practical implementation of the intelligence process.

GENERAL PRINCIPLES

Principle of legality – Actions to be taken in implementation of this strategy should be in fully compliance with the Constitution, laws and other normative acts, local and international applicable in the Republic of Kosovo, with particular emphasis, respect of the forbidden actions determined according to the protection and privacy standards of the personal data.

Principle of human rights and free-

doms – guarantee of the freedom and human rights for all individuals - in various phases of implementation of the strategy (ILP).

Principle of priority – prevention and combat of all crime forms as well as provision of public safety is the main priority for the institutions of Kosovo, especially of the Police. Kosovo Police in this regard will be committed in maximum in utilization of intelligence resources to perform duties and responsibilities as better as possible as its own mission.

Principle of professionalism – Implementation of this strategy requires good experts, exchange of experiences, appropriate means as well as better practices. This means a combination of training, education and professional development for the Kosovo Police and special attention for recruitment of only specialists of the high and proven quality.

Principle of continuity – Activities should be seen as a part of an ongoing strategy. This is especially important because there are going to be time constraints administrational/procedural as well as for the reasons that various initiatives/activities will be necessary to be related with the actions that will last several years.

The principle of continuity - Activities should be seen as part of an ongoing strategy. This is especially important because there are time / administrative / procedural limits as well as for reasons that different initiatives / activities will be necessary to relate to actions which will last for years.

The principle of confidentiality - Kosovo police personnel who will directly or indirectly be involved in the process of Police Intelligence must have the knowledge and commitment to confidentiality. All Police Intelligence data should be stored in a system protected from unauthorized access.

The principle of cooperation and coordination - All participants should strive to create a unified approach, taking into account all sections that may affect the prevention and combating of crime.

International cooperation - Kosovo police in the implementation of this strategy will be devoted to cooperation and coordination of police activities at regional and international level. Kosovo Police should try to become a reliable and professional partner of regional / international cooperation.

Departments of operations, investigations as well as the border police department.

Practical realization of the meeting and reporting of information from the sources in disposition

Department of Human Resources

Prepares plan programs based on the identified needs and organizes respective trainings, and allocated human re-

sources in accordance with the needs of this model.

Departments of Supporting Services

Offer necessary conditions through ensuring the physical infrastructure (work environment), technical and technological and other material resources.

Directorate of Intelligence and Analyses (DIA)

Responsible for implementation of intelligence process, that will be filled with respective documents and procedures.

Directorate of International Cooperation in the field of Rule of Law (ILECU) It is Responsible for national and international cooperation and coordination.

The Directorate of Strategic Planning and Legal Issues (DSPÇL)

Is Responsible for all normative acts, procedures and job descriptions.

Implementation

Complete implementation of the Strategy and Action Plan "Intelligence Led Policing" is planned to be realized in a five (5) year period of time, starting from the approval date, while the project coordinator will coordinate activities of all working groups in its implementation.

Monitoring

Implementation of this strategy will be monitored continuously by the Ministry of Internal Affairs and General Director of KP, including possibility of inspection and audit in all implementation phases.

Evaluation and review

Evaluation and review of the achieved progress and eventual obstacles that can be faced during the implementation of the Strategy and Action Plan will be done annually.

Specific duties and concrete activities on implementation of the strategy including deadlines, as well as budget planning are foreseen on action plan attached to this strategy.

Except promotion of this unit, Kosovo Police in celebrating this day has been very active in the field of raising the awareness of the wide opinion for protection and care for the environment.

During the manifest held in the Nënë Terezë square the Unit of bicycles has been engaged, who besides police works in keeping public peace and order during the manifest in a symbolic way they have forwarded the message to citizens to use bicycles in order to not have a polluted environment.

All activities are finalized with a rock concert with most famous groups of Kosovo and a group from Albania, held in Nënë Tereza square with the motto "With rock against the environment crimes".

OPERATIONS

SOME OF THE SUCCESSFUL OPERATIONS OF THE FIRST SIX MONTHS FOR 2013

TEN ARRESTED FOR ORGANIZED CRIME AND CORRUPTION

In this police operation realized by the special anti-corruption department under the lead of Special Prosecution of Republic of Kosovo on 17.4.2013, 10 persons are arrested under the ground suspicion that the same committed criminal offences "organized crime", "misuse of official duty or official authorization", "bribery", and "influencing". Based on the police investigation, the suspects acting from the various positions as in institutions, state and business, abusing their official positions, have benefited illegally for themselves and the others.

OPERATION CODED "BORDER" RE-SULTED WITH SIX ARRESTED PER-SONS

During the realization of this police operation six persons are arrested under the ground suspicion of committing the criminal offence "smuggling with weapons, goods and organized crime".

After a professional investigative work, police investigators from the Directorate of Investigation of Organized Crime on 3.4.2013 realized a police operation at three different locations in Prishtina region more precisely at the town of Podujeva.

The arrest of persons is done based on the ground suspicion that this criminal group in an organized way, committed criminal offences benefiting illegally.

OPERATION "THE NET" HAND-CUFFED FOUR SUSPECTS

Police operation "The Net" realized by police investigators of Directorate of Investigation of Organized Crime handcuffed eight suspects, on ground suspicion that the same have committed the criminal offence "contraband with migrants", "falsification of documents" and "orga-



nized crime". This successful police operation was realized at Prishtina, Mitrovica and Peja region. In this police operation there are confiscated many material evidence, hundreds of falsified documents, passports of different countries, different certifications, copies of visas, weapons, telephones and equipment for printing of falsified documents like lap tops, color printers and other things.

AUTO-CRIM UNIT IN ACTION

VEry successful during this year were also the Unit of Auto Crimes which in cooperation with Kosovo Customs conducted many police actions where as most successful there were: operation at auto market in Malisheva municipality, where 33 vehicles were seized, 27 of the seized vehicles are suspected for tax evasion and 6 of them suspected for falsification, for which a police case is open for further investigation.

The other police operation was conducted by the Regional Directorate of Ferizaj, which resulted on 7 seized vehicles, 6 of them suspected for tax evasion and one of them for falsification.

OPERATIONI "TERMINAL" HANDCUFFS FIVE PERSONS

In the police operation coded "Terminal", after an investigative work, investigators by the Directorate of Investigation of Organized Crimes, on 5.6.2013 arrested five suspects on the ground suspicion of committing the criminal offence "organized crime", "smuggling with goods" (medi-

cine medicaments).

While conducting police investigations applying the secret measures it was detected that a criminal activity is going on and in total coordination with the respective prosecutor, police investigators acted in the field, where they arrested suspected persons to whom there are found and confiscated goods and medicinal medicaments smuggled from Macedonia to Kosovo. This arrested group of persons was composed of three Kosovo citizens and two from the Republic of Macedonia.

THEY CLONED BANK CARDS BUT COULD NOT ESCAPE FROM THE PO-LICE OPERATION "CLONING"

Ection of Investigation of Cybercrimes, in Prishtina during a successfully organized and implemented police operation, arrested six persons under the ground suspicion of committing the criminal offence "hacking into computer system, falsification of bank cards and organized crime" Also during this operation some houses and annexes of suspected persons were searched, which resulted with the seizure of some electronic equipment as material evidences. It is suspected that these equipments were used for cloning bank cards.

ANTI-DRUGS, THIS YEAR AS WELL, STARTED FURIOUSLY WITH THE OP-ERATION "BEGINNING"

In a successful operation of Directorate of Investigation of Trafficking with Narcotics in the first part of February with the support form other police units in Peja region, realized the operation coded "Beginning". During this operation two raids are done in two locations, in which case four suspects are arrested and 122 kg of narcotics are seized, suspected to be of marijuana type as well as other things as material evidence.

OVER 12 KG NARTOCICS SUSPECTED TO BE HEROIN

ANother police operation realized in combating trafficking with narcotics, resulted with the confiscation of over 12 kg of narcotics suspected to be heroin divided in 24 plastic bags. A police operation, which was preceded by information analyzed and treated seriously by police investigators, resulted successful.

IN TWO SEPARATE POLICE OPERA-TIONS, SEVEN PERSONS SUSPECT-ED FOR TRAFFICKING WITH HUMAN BEINGS, ARE ARRESTED

POlice investigators of the Directorate of Trafficking with Human Beings in two separate operations, realized on 8.5.2013, arrested seven suspects on ground suspicion of committing the criminal offence "trafficking with human beings" as well as they identified two trafficking victims. In a police operation realize din the Prishtina region are arrested two suspected persons of committing criminal act "trafficking with human being" and one trafficking victim was identified.

As a continuance of the previous investigation another operation was realized in the Mitrovica region, where three suspects where arrested on the ground suspicion of committing the abovementioned criminal offences and one trafficking victim was identified.
