

Don't be silent - stop trafficking in human beings



Within the awareness raising campaign against the trafficking in human beings "MOS HESHT-Ndal trafikimin me njerëz" ("DON'T BE SILENT-Stop trafficking in human beings) held in Kosovo, Kosovo Police, respectively the Directorate of Investigation of Trafficking in Human Beings, in cooperation with the Directorate of Community Policing and Prevention, today on 26th of October 2020, conducted and activity at the high school "Sami Frashëri" in Prishtina

This activity intended the internal and external awareness raising in prevention and manner of referring of cases related to the criminal offense of trafficking in human beings.

This campaign was enriched by a short lecture for the pupils and they were informed related with this phenomenon, and awareness raising materials were handed over such as:

1- Card with the indicators of forced

labor, beggary and sexual abuse of the victim of trafficking.

2- Information brochures for pupils on knowing the forms of criminal offense of THB and referring to the cases.

3- Protective masks against the COVID-19 with the moto "MOS

HESHT- Ndal trafikimin me njerëz" ("DON'T BE SILENT-Stop trafficking in human beings).

During the whole time while the activity was going on, the recommendations from KNIPH on protection from COVID-19 were respected.

in terms of recognizing the forms of criminal offense of the THB and referring cases (Albanian and Serbian version).


Awareness raising materials were distributed at all border crossing points of the Republic of Kosovo connecting to neighboring countries.

Platform

THE APPLICATION EASING THE CASE REPORTING FOR CITIZENS "INFORM THE POLICE" HAS BEEN LAUNCHED

The program digital reporting "Inform the Police"

The application "Inform the Police" is an electronic platform, enabling citizens to report all cases at Kosovo Police. Kosovo Police provides quality police services, law enforcement and high level of public safety for all.

The application "Inform the Police" is a new alternative, unlimited in time, possibilities and territory that within a few seconds a citizen can share information with the police.

The application provides transparency and confidentiality, because all reporting are documented and the announcement from the citizens can be anonymous depending on the selection of the citizen.

Use of application

The access in the application can be done in few steps:

FIRST STEP

Download the application

The application can be downloaded into the "Play store" platform for the devices with Android operating system and in the future it will also be available for the iOS as well.

SECOND STEP

Selection of the language

In this page a language can be selected by clicking in the respective buttons such as Albanian, Serbian and English. The users of the application are responsible for all malevolent information sent to Kosovo Police.

THIRD STEP

Agreeing with the terms of use

1. Is done by clicking "I agree with terms and conditions" confirming with the "agree" button.



2. If the user does not agree with the terms of use then they will not be able to use this application.

Kosovo Police reserves the right to alter or modify term of use of application, in compliance with the possible legal modifications in the field of protection of personal data and privacy.

The user may unregister from the use of this application at any time, where all their personal information collected for the use of this application will be deleted automatically.

STEP 4

Uploading and sending the information through this application

Reporting categories

The application has seven reporting categories: Violence, theft, traffic, weapon, corruption, drugs, and other.

All reporting containing pictures, text, and description will be stored in the Kosovo Police web system, used only by Kosovo Police for legal intentions and in compliance with the law.

If the reporter selects one of the reporting categories and clicks it, then the respective interface will be displayed.

i.e. the Traffic icon: after clicking in the icon "Report", the reporter will receive the notification automatically that the information was received and addressed by the Police.

THE RESPONSIBILITY AND SPEED OF SPREAD OF INFORMATION IN PUBLIC

If we leave gaps in communication with the public, then we create a lot of opportunities for interpretations based on desires, and the trust is faded, decreased and the interest to follow the events is lost

Informing means talking about events, to convince people with facts, being fast and accurate. But in order to be successful for the data you spread, we must wrap them with moral responsibility, genuine communication and culture in expression.

Information is any kind of news making communication possible.

When spreading the information to the public one must take into account its weight. It's the way you publish it that determines its weight.

A complete news is when it has reliable sources, when it contains accurate information, when it is published in time, it has an understandable description, it arouses interest when it comes out and the recipient has understood that news in the right way.

In order to achieve all these characteristics and to give complete information, one must first have patience, prudence, skill and restraint. You have to make connections between givers and receivers, to enter the world of both parties, to be able to understand from both sides because that way you understand whether you have managed to say correctly what you have planned.

If while we communicate with the public we leave gaps, then we create a lot of opportunities for interpretations based on desires, and then the trust fades, the interest to follow the events disappears.

Often under the pressure of time,

information may come out deficient, but this should not be allowed because the formulation of information plays a role in this. You take powerful words with meaning, placed correctly and the information is completed on time as well. The contemporary world has brought us many ways of communication and today the speed of publishing information plays a big role in the sphere of media. As the communication got easier the seriousness of writing has been lost. Today you can get information quickly, anywhere, but with less culture, less understanding, less responsibility!

Therefore, the information released by the institutions must be well grounded, logical and become an example of communication for today's fast A complete news is when it has its reliable sources, when it contains accurate information, when it is published in time,

has an understandable description, arouses interest when it comes out and when the recipient understands the news in the right way

networks. Based on the law in force, proper information is responsibility of every institution.

It is everyone's responsibility!

Operations

SOME OF THE PO

Eleven persons
arrested for involving
in criminal offense
"import, export,
supply, transport,

The Directorate of Investigation of Organized Crimes (DHKO) after a several months of investigation, by the order issued by Basic Court Prishtina, Special Department, in the morning hours date 29.09.2020 conducted a police operation in Peja region. Houses and additional facilities (10 of them) have been searched in various locations during this police operation. Investigators of the DHKO have been supported by the following police units: Special Operational Unit (NJSO), K9 unit and two units from the Peja Police Stations.

Eleven suspects have been arrested during this operation.



During this operation these evidence have been found and seized:

- 3 (three) semi-automatic long barrel weapons
- 6 (six) small weapons
- 2 (two) magazines
- 1 (one) pair of binocular
- 180 rounds (various caliber)
- 2000 (two thousand) euro
- 2 (two) vehicles
- 12 (twelve) mobile phones
- By the decision of the competent prosecutor, eleven suspects have been taken to custody for 48 hours.



Kosovo Police in its efforts on fight of negative phenomenon and criminal offenses after the investigations conducted on 23.09.2020 arrested one suspect for the criminal offense of "counterfeiting money".

Kosovo Police through its operational methods on 16.09.2020 received

information that one suspect is producing counterfeit money in various banknotes: 5 (five) euros, 10 (ten) and 20 (twenty) euro.

The Unit of Investigation of Economic Crimes and Corruption – Prishtina undertook immediate investigative and operational actions and it was found that the person with the initials L. A. male/Kosovar is in the process of producing an amount



of 50.000 euro of counterfeit money for distribution in the market.

Related to the case the competent prosecutor and judge and a verbal order was given for the search of the location suspected for the counterfeit money production.

During this control of the suspected location the police units have found and seized;

- One printer together with 5 (five) euro attached in the printing side.
- Sixty five (65) sheets of A4 paper with falsified money in both sides
- Two hundred and two (202) sheets of A4 paper with five (5) euros printed in both sides
- Forty four (44) banknotes of 20 euros suspected to be falsified,
- Seventy four (74) banknotes of 10 euros suspected to be falsified,
- One hundred and sixty (160) banknotes of 5 euros suspected to be falsified,
- One (1) banknote of 50 euro suspected to be falsified
- Foil with the money security signs and
- Two cell phones,

After the carried checks, the suspect is arrested and interviewed. In consultation with the prosecutor on duty of the BP Prishtina the suspect was taken to detention for 48 hours.

LICE OPERATIONS

Police in Gjakova detects the location where plants suspected to be cannabis sativa were being cultivated



Kosovo Police respectively the Investigation Directorate of Trafficking with narcotics - Gjakova received the information that in a house in Gjakova are being grown cannabis sativa plants. On 30.07.2020 at about 10:35 in talks with the on duty prosecutor after receiving the verbal order by the Basic Court in Gjakova it was initiated the search of a house in the presence of two witnesses. During the search in the basement of the house it was found a laboratory with ventilation, with special lights and other elements serving for growing cannabis sativa.

As a material evidence are seized

- Fourteen (14) vases with plants (suspected to be cannabis sativa) with the height of 90-160 cm.
- Eleven (11) plants in drying process (suspected to be cannabis sativa) found in the ceiling of the house.



- Four bottles (1.5 and 2 liters) filled with the oil suspected to be cannabis oil,
- Two tends (glasshouses) for cultivation of the cannabis sativa, two electricity regulators with two lights, two air fresheners, 1 ventilator and one thermometer for measuring temperature and
- Six bullets of an unknown caliber On duty prosecutor from the Basic Prosecution of Gjakova came at the scene and instructed that a case of "cultivating hashish plant, cocaine plant or cannabis plant" be initiated.

A suspect arrested for attempting to enter Kosovo hiding and transporting narcotics

On 10.08.2020 at around 11:20, Kosovo Police, respectively the border officials at the border point Vërmicë, while recording into the system the vehicle "Seat" with local license plates entering from Albania to Kosovo, officers picked it up for a detailed control in the second line of control

In this detailed control conducted by the police officers in cooperation and coordination with customs, in the front part of the engine of the vehicle were found fifteen (15) plastic bags filled with suspected narcotic substance of marijuana, suspected weight of about 6kg.

The case was reported to the Directorate for Investigation and Trafficking with Narcotics, the forensics unit and other relevant units for further proceedings and investigation of the case.

By order of the Prosecutor of the Basic Prosecution DKR Prizren, the case was initiated for the criminal offense "Unauthorized Purchase, Distribution, Transportation, Production, Exchange, Mediation or Sale of Narcotic and Psychotropic or Analogous Substances", against the suspect (EL year of birth 1966).

All further actions against the suspect will be undertaken in cooperation and coordination with the competent Prosecutor.

AWARENESS ACTIVITIES AND PROTECTIVE N SERVICES DURING THE COVID-19 PAND

I. Kosovo Police Awareness Activities against COVID-19

The Directorate of Health Services / GPD, within the Specific Objectives of work:

"Health and Psychological care for KP members", carries out activities aimed at raising awareness about health and psychological care for Police Personnel

Taking into account the situation created by the COVID-19 Pandemic, the Directorate of Health Services / GPD has undertaken some Awareness Activities, before the emergency state of public health is declared, at the level of the Government of the Country.

Awareness activities by the Directorate of Health Services / GPD, have started in February 2020, which are as follows:

- 1. Lecture "How to protect from Corona virus"
- 2. Posters "No fear, more caution from COVID-19"
- 3. Brochure "Corona virus and mental health"

Purpose: Awareness-raising activities have been undertaken to inform the Police personnel about the newest Virus in the world, which is causing the disease called COVID-19, and how to protect ourselves from this Virus, what preventive measures should be implemented by each employee in KP, based on the recommendations of the National Institute of Public Health of Kosovo - NIPHK.

Another goal has been to manage anxiety and panic towards something hitherto unknown and to deal with such situations that cause fluctuations in the psychological and emotional sphere.

1. The lecture "How to protect ourselves from Corona virus" was initially held on Border crossing points, because in the initial phase of the COVID-19 Pandemic, KP Members at border crossing points were more exposed at risk, due to the arrival of passengers from different countries of the world affected by COVID-19.

Purpose: The lecture in question provided clarifications and professional advices about the nature of SARS-COV-2 and about the preventive measures to be taken for protection against COVID-19, according to the NIPH Guidelines.

2.The posters "No fear, more caution from COVID-19", were prepared based on the Instructions of the National Institute of Public Health, and were distributed to the Border Police, into two KP Special Units Camps, in all KP Regional Directorates, to the Directorate of Basic Training (with special emphasis for Police Cadets) and the General Directorate of KP / GDP.

Purpose: The awareness posters "No fear, more caution from COVID-19" have influenced the Police Personnel to be aware of the preventive measures of COVID-19, according to the NIPHK Guidelines.

3. The brochure "Corona Virus and Mental Health"

The brochure "Corona Virus and Mental Health "was printed in 1400 copies, into three languages: Albanian, Serbian and English, and distributed throughout the Kosovo Police.

Purpose: The brochure "Corona virus and mental health" has influenced in informing Police personnel about the emotional and psychological impact caused by COVID-19, as well as the measures that should be taken to maintain the mental health of the KOSOVO Police Personnel

II. The Committee for coordination and assessment of the Emergency Situation with Coronavirus COVID-19

All the recommendations, instructions, SOP's issued by this Committee, have been forwarded on time by DHS / DLE to the senior management of KP, DPP Command Center, DLE Information Office and to all KP Regional Directorates, so the committee through our representation has had a special role and importance being also as a bridge between KP and MH.

III. Kosovo Police Protective Measures against COVID-19

1. Health support for the Police officers with high risk to COVID-19

With the authorization of the General Director of Kosovo Police, DHS / GPD there have been identified KP Officers who have high risk diseases from COVID-19, providing support to Police Personnel with the diseases of (Diabetes,

Heart Disease including High blood pressure, Kidney disease, respiratory system, etc..) with a recommendation to stay at home, affecting in prevention of the spread of COVID-19 disease, and with a direct impact on protecting the health of Police Officers, regardless that they have been more at risk of being infected with SARS-COV-2 and have more severe lethal consequences.

2. Disinfection of all Police facilities

The Directorate of Health Services /GPD with the aim to prevent the spread of COVID 19, has drafted the action plan Disinfection of all Police facilities throughout Kosovo.

Purpose: Disinfection with the help of chemicals, physical or biological, has been the elimination of microbes, viruses that cause disease in the environment where man lives and works.

3. Supply of Police officers with protective equipment (Protective masks, Disposable gloves, disinfectant against COVID-19)

The Directorate of Health Services / GPD in order to protect all Police Personnel from COVID-19, has taken protective measures to supply Police Officers with protective equipment such as; Protective masks, gloves, disinfectants, with

emphasis on those Police officers who have been on the field, and direct risk exposure with COVID-19.

Donors of protective equipment have been, initially the Ministry of Health (MoH), then the United Nations Development Program (UNDP), the Organization for Security and Cooperation in Europe (OSCE), the European Union (EU).

Purpose: The supply of police personnel with protective equipment has been due to the fact that the entry routes of the virus are the upper respiratory tract, therefore this has affected the preservation of their health by COVID-19.

IV. Epidemiologic Tracking

Since the moment of declaring a state of emergency of public health and announcing the first cases of confirmation patients with COVID-19 in Kosovo. we have started with the Epidemiological Tracking of cases that have been presented in Kosovo. epidemiological research has been done and recommendations

for self-isolation have been given.

Purpose; Epidemiological tracking is the research towards identifying the source of infection, identifying the persons carrier of infection, their direct and indirect contacts and their isolation, in favor of stopping the spread of infection to other people.

Several tricks on how to spot counterfeit items

Nowadays, counterfeit items and products are circulating more and more. However, it is very difficult to distinguish such a product as it often looks like there is no difference. The Bright Side has listed several simple tricks and tips to help you distinguish counterfeit items.

Check the metal on expensive watches.

Put the watch close to your ear and if you hear any sound, it is better to leave it. Also the engravings on beautiful watches are usually sharper. Watches that are not original are usually made of cheaper and lightweight materials.

Check the logo

Counterfeit chargers are not only of poor quality, but they can also be dangerous because they do

not pass the proper certification. Check the original logo on the phone with that of the charger: it has a yellow color instead of the white and the plastic looks weaker.

Check the seam on clothes and shoes.

The quality of original and expensive clothing also varies. Sewing will be stronger on authentic items, unlike others. Original dresses and shoes often have more stitches.

Check the labels on the clothes.

Always check labels. They can say a lot whether the brand is counterfeit or not. Counterfeit manufacturers usually use lower quality factory fittings, so labels and tags can be badly sewn. Also the label will be of a different color and of poor quality compared to the original part and the letters in it may have different space.

Check the buttons.

If you want to buy a jacket or coat pay attention to the buttons on the inside and outside. Good brands use good quality plastics with the company name engraved. Counterfeits use lightweight plastic and will sometimes be unlabeled.

A French tourist "Stole" sand on an Italian beach, he is ned

An unusual event happened in Italy. A French tourist was fined 1,000 euros after trying to leave Sardinia with more than 1.8kg of sand in his luggage.

According to CNN, the white sand of the Italian island is protected by law while tourists may face fines and even jail for taking it from local beaches. The man, who was not identified by name, was

apprehended at Cagliari Elmas Airport on 1st of September after stealing 1.8 kilograms of sand, which he had placed in a bottle. "The bottle was seized and



is currently in our hall," said a spokesman for CNN. Meanwhile, in 2017 a regional law was introduced, which made the removal of sand from the beaches of Sardinia in Italy an illegal act.

A person sentenced to 30 years in prison, reason completely unbelievable

James Robert Scott is one of the prisoners expected to leave the cell in 2023. But the reason he spent 30 years in prison is very interesting. Also

known as Jimmy, in 1993 in Missouri, he decided to destroy part of the Mississippi River embankment to flood the road and block his wife Suzie, who was working across the river, in order to have a party and drink with friends. But this action did not go so well, as the damage was great. Over 57 square kilometers of land were flooded and it also became impossible to use a bridge for 71 days. So more than 14,000 hectares of land were under water and that was a huge financial loss, hundreds of thousands of dollars. This way, he ended up in prison being sentenced to 30 years in prison. He is expected to be released from prison in 2023.

Do you know how many times plastic water bottles need to be re lled?

Plastic bottles unfortunately contain Bisphenol A, a chemical that is dissolved in water and returns to a shelter for many dangerous bacteria.

In a single use, these bacteria are accumulated exactly in the mouth of the bottle, where we place the lips, so you can imagine what happens with the reuse of these bottles.

The mouth of the bottle can never be sufficiently cleaned and always remains wet, turning it into a 'dance floor' for bacteria.

This chemical has an extremely dangerous effect on human hormones, especially when the bottle is heated by the sun or reused.

Consequently, Agroweb.org experts recommend that if given the opportunity, you should not buy water bottles from the ones we have seen commonly exposed to the sun for hours in many markets across the country.

Experts advise the use of the plastic bottle only once and replacing it with glass bottles. This way, you will protect not only your health but also the environment where we live.

Why unwashed clothes should not be left in the same room for more than a day

It happened many times that you leave in a chair in the room where you sleep, clothes intended for washing. This may seem perfectly normal, but it causes problems for our health.

According to experts, human odors that remain on unwashed clothes act as a "magnet" for mites and many insects even if we do not see them with the naked eye. According to a new study by experts from the University of Sheffield, unwashed clothes we throw in the bedroom or hotel room are a magnet for insects.

Researchers on the subject concluded that we should put clothes in a basket and not

leave them there for many days. If you are traveling and staying in a hotel now, it is best to pack them in a bag before washing them.



Do you know how long a person can stay awake?

A person stays awake on average for about 16 hours and 10 minutes before falling asleep again. Those who stay awake much longer and consequently sleep less are considered medically sleep deprived.

According to experts, staying awake for 24 hours reduces the brain's ability to receive information by 40%, and the symptoms that appear after 48 hours resemble those of a blood alcohol level of 0.15%. Lack of sleep can even be fatal after 10 to
